Tax Calculation

This article describes how taxes are assessed for paid Bitwarden subscriptions. Information about your Bitwarden subscription is available:

- For personal users, from the Password Manager **Settings** → **Subscription** menu.
- For organizations, from the Admin Console **Billing** → **Subscription** menu.

United States

If your billing address is in the United States, sales tax for your subscription is assessed based on the ZIP / Postal code associated with your payment method. The sales tax on your subscription can be viewed in the invoices available on the **Billing history** tab.

Value added tax (VAT)

If your billing address is in Australia, Canada, the European Union (EU), or the United Kingdom (UK) you may be subject to value added tax (VAT) depending on your subscription type:

Personal subscriptions

Note

In 2025, Bitwarden has begun assessing VAT separately from the cost of personal-use subscriptions.

For personal subscriptions, including [Premium individual](#) and [Families organization](#) subscriptions, VAT is assessed and included as a separate line item on your invoice.

Business subscriptions

For business subscriptions, including [Teams](#) and [Enterprise](#) organizations, VAT is included in the cost of your Bitwarden subscription **if you have provided a valid VAT/GST Tax ID**. You can provide a Tax ID during signup, at any time from the Admin Console **Billing** → **Payment method** view by selecting **Change payment method**, or by contacting Customer Support:
