## FAQs

### Are URLs encrypted in Bitwarden?

Yes, all URLs are encrypted within the Bitwarden vault and never shared with third-parties. For more information on the Bitwarden business model, please see the post [Defining and sustaining value for Bitwarden users](#).

### What data is encrypted within my Bitwarden vault?

All vault data within each Bitwarden account is [end-to-end encrypted](#) with AES-CBC 256-bit encryption before being stored anywhere.

[Vault data](#) that is encrypted includes, but is not limited to:

- Names of folders, collections, items, & attachments
- All fields for all item types (logins, credit cards, identities, and secure notes)
- All custom field name/value combinations

## What is administrative data?

Administrative data contains information connected to your Bitwarden account, including account creation, usage of the Bitwarden Service and support, and billing. Learn more about administrative data in this [help article](#).

## What are the backup and retention policies at Bitwarden?

Bitwarden maintains automated backups for disaster recovery, which operate in accordance with the company's data retention policies. Bitwarden databases use data encryption and backups are encrypted at rest.

If a user were to [delete a Bitwarden account or organization](#), the account or organization in question would be permanently deleted, including all data associated with it. Learn more about how Bitwarden stores your data in this [help article](#).

## Do I need a Premium account to share passwords?

You can share for free! Any account can create a free 2-person organization, where you can invite one other Bitwarden user to share passwords between you both. If you join a Family, Teams, or Enterprise organization, you are automatically upgraded to a premium account for free.

## What is a Bitwarden organization?

An [organization](#) relates Bitwarden users and vault items of a particular entity (family, company, team, enterprise, or group of people). Members of an organization are granted access to an organization vault, where vault items including logins, identities, credit cards, and secure notes can be shared between users.

## How do I securely share vault items?

## How can I ensure the Bitwarden browser extension autofills my credentials?

Users should be aware that autofill on pageload is turned off by default. Visit this [help center article](#) to learn how to turn on this functionality. If you are still having issues autofilling credentials from the browser extension for a specific website, try setting up a [linked custom field](#) to force autofill. You should also disable your browser's built-in password manager to ensure autofilling with Bitwarden works as intended.
